WEEK IN REVIEW

- OFFICERS RESPONDED TO A REPORT OF A LARGE FIGHT IN THE 500 BLOCK OF BUCHANAN AVE ON 8/31. ONCE ON SCENE, OFFICERS LOCATED A LARGE GROUP OF INDIVIDUALS STREET FIGHTING. AS OFFICERS WORKED TO BREAK UP THE FIGHT, ONE INDIVIDUAL WITH A SUPERFICIAL STAB WOUND WAS LOCATED. THE VICTIM REFUSED TREATMENT AND WAS UNWILLING TO COOPERATE WITH FURTHER INVESTIGATION. NO ARRESTS WERE MADE.
- · OFFICERS RESPONDED TO A REPORT OF A MAN ATTACKING A WOMAN IN A STORE IN THE 1700 BLK OF 24TH AVE SW ON 8/25. PRIOR TO THEIR ARRIVAL, A CITIZEN ATTEMPTED TO INTERVENE AND WAS ALSO ATTACKED SUFFERING INJURIES. THE SUSPECT THEN LEFT THE AREA. THE INITIAL INVESTIGATION INDICATED SUSPECT WAS TRYING TO KIDNAP THE WOMAN WHO RAN INTO BUSINESS FOR HELP. OFFICERS LATER LOCATED THE SUSPECT WHO ATTEMPTED TO RUN FROM OFFICERS. THE SUSPECT WAS ARRESTED AND BOOKED INTO CCDC ON A COMPLAINT OF AGGRAVATED BATTERY AS WELL AS VARIOUS OTHER CHARGES AND OUTSTANDING WARRANTS.
- FEDERAL SENTENCING BEGAN ON 8/27 FOR TWO SUSPECTS ARRESTED FOR WIRE FRAUD AND AGGRAVATED IDENTITY THEFT. THE INVESTIGATION WAS INITIATED IN SEPTEMBER 2023 WHEN THE SUSPECTS ATTEMPTED TO PURCHASE A CAR WITH A STOLEN IDENTITY INITIAL FOLLOW-UP RESULTED IN WARRANTS AS WELL AS THE RECOVERY OF 2 OTHER CARS PURCHASED WITH STOLEN INFORMATION. EVIDENCE OF ADDITIONAL FRAUDULENT ACTIVITY, AND THE PERSONAL IDENTIFYING INFORMATION FROM NEARLY 400 PEOPLE OBTAINED THROUGH MAIL THEFT AND STOLEN RECORDS. IN FEBRUARY 2024, FEDERAL PROSECUTORS OBTAINED AN INDICTMENT FOR BOTH SUSPECTS. THE FIRST SUSPECT WAS SENTENCED TO 18 MONTHS FOR THE WIRE FRAUD AND 24 MONTHS PROBATION. THE OTHER SUSPECT CHANGED THEIR PLEA AS A RESULT AND IS EXPECTED TO BE SIMILARLY SENTENCED REFORE THE END OF THE YEAR
- ANIMAL WELFARE HAD 45 ANIMALS ADOPTED, 1 ANIMAL TRANSFERRED OUT TO RESCUE. AND 2 ANIMALS RECLAIMED BY THEIR OWNER THIS WEEK. ADDITIONALLY, THEY TOOK IN A TOTAL OF 52 ANIMALS. NORMAN ANIMAL WELFARE HAS 202 ANIMALS CURRENTLY IN THEIR CARE WITH 78 OF THOSE ANIMALS IN PLACEMENT WITH FOSTERS.
