WEEK IN REVIEW

- OFFICERS RESPONDED TO A DISTURBANCE IN THE 1000 BLK OF E. ROBINSON ST ON 9/8. INITIAL INFORMATION WAS THAT ONE INDIVIDUAL WAS ARMED WITH A KNIFE AND WAS ARGUING WITH ANOTHER PERSON. UPON ARRIVAL, OFFICERS LOCATED A VICTIM WITH A CUT ON THEIR HEAD AND BLOOD ON THEIR CLOTHING. THE VICTIM SAID THEY TRIED TO INTERVENE IN THE ARGUMENT AND GOT CUT IN THE PROCESS. THE VICTIM RECEIVED MEDICAL ATTENTION ON SCENE, BASED UPON THE DESCRIPTION PROVIDED, OFFICERS DEVELOPED A POTENTIAL SUSPECT. WHILE CONDUCTING A FOLLOW-UP PATROL OF THE AREA ON 9/9, OFFICERS CONTACTED THE SUSPECT. THE SUSPECT ADMITTED TO STABBING THE VICTIM AND WAS ARRESTED AND BOOKED INTO CCDC FOR ASSAULT WITH A DANGEROUS WEAPON.
- VICTORY NELSON ENTERED A GUILTY PLEA TO THE CHARGE OF FIRST DEGREE RAPE ON 9/11 FOR THE 2021 RAPE OF A NORMAN WOMAN. NELSON WAS SENTENCED TO 30 YEARS IN THE DEPT. OF CORRECTIONS. DURING THE INVESTIGATION, NELSON HAD 5 PREVIOUS RAPE VICTIMS FROM OTHER JURISDICTIONS COME FORWARD AND HAD THREATENED THE VICTIMS INTO NOT TESTIFYING. THIS INCIDENT OCCURRED IN 2021. NELSON WAS CHARGED IN 2023.
- OFFICERS ARRESTED A 17-YEAR-OLD FEMALE FOLLOWING A SHORT PURSUIT. ON 9/13 NPD RECEIVED MULTIPLE REPORTS OF A RECKLESS DRIVER INVOLVED IN MULTIPLE INCIDENTS ON THE EAST SIDE OF NORMAN INCLUDING A HIT AND RUN COLLISION, DURING THE DAY, WHILE CONDUCTING A FOLLOW-UP, OFFICERS SPOTTED THE VEHICLE WHICH WAS DETERMINED TO BE STOLEN AND ATTEMPTED A TRAFFIC STOP IN THE AREA OF LINDSEY AND 12TH AVE NE. THE SUSPECT REFUSED TO STOP AND CONTINUED INTO A NEIGHBORHOOD. THE DRIVER THEN ACCELERATED, LOST CONTROL, AND CRASHED THROUGH A FENCE IN THE 600 BLOCK OF SUNRISE STREET. THE SUSPECT FLED ON FOOT, BUT WAS ARRESTED AFTER A BRIEF CHASE. THE SCHOOL WAS PLACED UNDER A SECURE PERIMETER DURING THE INCIDENT, BUT NO STUDENTS WERE INVOLVED OR INJURED DURING THE INCIDENT
- ANIMAL WELFARE HAD 53 ANIMALS ADOPTED, 1 ANIMAL TRANSFERRED TO RESCUE, AND 5 ANIMALS RECLAIMED BY THEIR OWNERS THIS WEEK. THEY ALSO TOOK IN A TOTAL OF 70 ANIMALS AND CURRENTLY HAVE 182 ANIMALS IN THEIR CARE WITH 53 OF THOSE IN PLACEMENT WITH FOSTERS.
