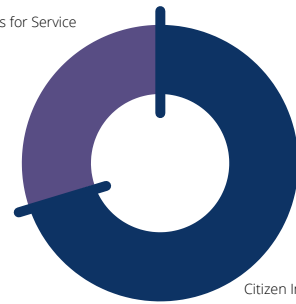

WEEK IN REVIEW

- OFFICERS CONTACTED A SUSPICIOUS INDIVIDUAL SUFFERING FROM SYMPTOMS OF SIGNIFICANT IMPAIRMENT IN THE 200 BLK OF N. COCKREL AVE ON 9/18. UPON CONTACT, THE INDIVIDUAL WAS UNCOOPERATIVE AND RAN FROM OFFICERS TOWARD THE AREA OF GRAY STREET AND PONCA AVENUE. THE INDIVIDUAL REMAINED COMBATIVE AND WAS TASED DURING EFFORTS TO TAKE HIM INTO CUSTODY. THE INDIVIDUAL WAS TAKEN INTO CUSTODY AND TRANSPORTED FOR MEDICAL TREATMENT DUE HIS IMPAIRMENT. A WARRANT FOR THE SUBJECT'S ARREST WAS REQUESTED. THE NEIGHBORING SCHOOLS WERE PLACED ON A BRIEF SECURE PERIMETER AS A PRECAUTION. THERE WAS NO ACTIVE THREAT TO SCHOOL SAFETY.
- NPD INVESTIGATED NUMEROUS GENERIC THREATS TO SCHOOL SAFETY REFERENCING VARIOUS NPS SCHOOL SITES. INVESTIGATORS DETERMINED THERE WAS NO INDICATION OF AN IMMEDIATE THREAT TO STUDENT OR STAFF SAFETY AND HAVE NO INDICATION THAT ANY KNOWN THREATS ARE CREDIBLE. CHARGES FOR THREATENING ACTS OF VIOLENCE WILL BE SUBMITTED TO THE CLEVELAND COUNTY DISTRICT ATTORNEY'S OFFICE FOR THE INDIVIDUALS RESPONSIBLE.
- OFFICERS RESPONDED TO A REPORT OF AN INJURY COLLISION IN THE 1400 BLOCK OF 12TH AVE SE ON 9/19. A MOTORCYCLE AND VEHICLE WERE INVOLVED IN THE COLLISION. THE INITIAL INVESTIGATION INDICATES THAT THE DRIVER OF THE MOTORCYCLE WAS TURNING EAST ONTO COMMERCE DR FROM 12TH AVE SE WHEN IT WAS HIT FROM BEHIND BY A VEHICLE TRAVELING SOUTHBOUND ON 12TH AVE SE. THE DRIVER OF THE MOTORCYCLE WAS PRONOUNCED DECEASED AT THE SCENE. THE INVOLVED VEHICLE LEFT THE SCENE IMMEDIATELY FOLLOWING THE CRASH. OFFICERS LOCATED THE INVOLVED VEHICLE ABANDONED IN THE 800 BLK OF E. ALAMEDA ST. VARIOUS SEARCH EFFORTS TO LOCATE THE SUSPECT THE NIGHT OF THE COLLISION WERE UNSUCCESSFUL. OFFICERS HAVE SINCE IDENTIFIED THE DRIVER OF THE OTHER VEHICLE AND ARE ACTIVELY WORKING TO COMPLETE VARIOUS ELEMENTS OF FOLLOW-UP. THE COLLISION REMAINS AN ACTIVE INVESTIGATION BY THE NPD/OU/DPD CRT TEAM.
